Renewal of IBA Group Health Insurance for Retirees' for the year 2021-22 Time Extended

The validity period of IBA Group Health Insurance Policy had been expired as on 31.10.2021 and renewal of the policy w.e.f. 01 November 2021 has taken effect. Though the last date for renewal of the policy was till 22nd October 2021, Bank had entertained applications received even up to 29.10.2021.

It has been informed by Bank that the National Insurance Company has now given an extended window period to the Retirees who could not renew the policy on time owing to various reasons. The detailed guidelines issued by HR Department in this regard is reproduced here.

The **method of Generation of new E Card** for Retirees for the period of 2021-22 is also covered in the guidelines.

Those eligible members who could not renew the policy may go through the contents and do what is necessary in case they wish to get covered under the scheme w.e.f 01.12.2021.

Please find the below given communication regarding Extended Window Period and E card generation in respect of Retired Employees Medical Insurance Policy (2021-22).

Extended Window Period

M/s. National Insurance Company has now given an extended window period to the Retired Employees who could not renew the policy on time due to various reasons. The instructions regarding the renewal during extended window period are as follows:-

- The window period for renewing the policy has been extended till 30.11.2021 for those eligible retired employees who could not renew the policy on time due to various reasons.
- The extended window period facility will be available only for the Retirees who were covered under the policy year 2020-21.
- For those retirees who wish to join the Medical Insurance policy (for the year 2021-22) during the extended window period, the period of coverage will be effective from 01/12/2021 to 31.10.2022.
- The beneficiaries shall have to pay the premium amount applicable for the full year, after deducting the partial contribution from the Bank in eligible cases.
- Duly filled application forms has to be submitted by the Retired Employee on or before 22.11.2021 to HR Department directly or through the mail medicare@federalbank.co.in
- Applicable premium will be debited from the beneficiary account between 25.11.2021 and 28.11.2021. Once the premium is remitted, no option change will be allowed.

- 3) Corporate Name: Federal Bank (Type Manually)
- 4) Policy Year > Select 2021-22
- 5) EmpID > Enter the PF Number
- 6) Click the Submit Button

PS. Though our members may be holding E-Card which was effective from 01.11.2020, it is advisable to download a new E Card which is valid from **01.11.2021** and keep with them until a new card is issued by Company. Hospitals may insist for a new card so as to make sure that the policy is renewed. Also, the card shows the status of Super Top-up coverage. It is better to download the card from Laptop/Desktop, as the age of beneficiary gets trimmed when downloaded from smart phone.
