Dear Members,

FBROF – Directory of Members – Vol 2 as on 30-6-22

Hope our members are aware that our Forum has been periodically releasing Directory of its members, for their reference. The Directory has been highly useful and our members keep it as a treasure.

The directory was first published on 31-12-2007. Thereafter, Directories were released on 31-07-2009, 31-03-2011, 05-10-2012, 11-11-2014; 31-05-2016 (Vol 2), 23-06-2018 (all members) and 31-07-2019 (Vol 2). The last Volume released in 2018 contained 1431 members and its second part contained 158 members as on 31-07-2019. Our membership has been growing continuously over the years. Since publication of the last volume about 500 members were newly added and now we are 2000 +.

To release a printed Directory of all members with updated addresses and photograph etc. is a herculean task and it will take a long time to accomplish it. The cost too is enormous for printing and sending it to members pan-India. Also, if we go for periodical release of supplementary volumes with details of only new members, one has to refer to different volumes to search for details.

To overcome this we have conceived the idea of **e-Directory**. With the technical support of the developer of our website, an e-directory was released earlier. However, it has the limitation of file size and a volume could not hold details of more than 200 members at a time. Finally, one of our Dy. General Secretaries Sri. Mohammed Ansari has developed an e-Directory using the Mail Merge facility in Microsoft Office. In this task he was assisted and supported by a team of our members Sri. Vinu Jose (Retd. AGM, IT Dept) and Sri Venkateswaran P (presently working as our Office Manager). Kudos to the entire team behind.

Now, we herewith release the **draft** e-Directory containing details of 636 members who joined the Forum since publication of the directory as on 23 June 2018 till 30-06-2022. It is in PDF format, in colour, 106 pages, sorted alphabetically. It may be noted that the last printed volume II (released as on 31-07-2019) is merged with the draft **e-Directory** being released now and as such there are only two volumes covering all our (2005) live members joined up to 30 June 2022. The **draft e-Directory** is being released through our official WhatsApp Groups, along with this circular.

Members are requested to go through it and inform discrepancies, if any, with regard to the data contained therein, by email / WhatsApp latest by 31-07-2022. Suggestions too are most welcome, for improvement of the directory. We intend to release a corrected version of **e-Directory – Vol 2** in our 27th AGM proposed to be held in September 2022, in FISAT in hybrid mode. Also, it will be uploaded to our website. Members can download it and keep it for quick reference. The advantage here is that it can be updated periodically, with details of new members joining thereafter.
