Release of PF arrears to Resigned/ Deceased Employees

We are informed by HR Dept that details in respect of cases where both pensioner and his/her spouse were deceased are not readily available with them and hence distribution of PF arrears to such category has become a difficult task. In such cases payment can be effected only after getting the details of their legal heirs.

Likewise, several employees who were in the services of Bank as on the cut-off date in September 1992 might have been deceased or left the service of the Bank subsequently. Details of such of those beneficiaries are also required for releasing the arrears.

Hence our Zonal/ Area Secretaries and Help Desk members are requested to bring this matter to the attention of legal heirs of deceased / resigned employees and advise them to put up claim in the format already forwarded in the group to Vice President, HR Employee Relations.
