AIBPARC Decides submission of Mass Memorandum online by members of all constituents

All Members,

As decided in the last Governing Council of AIBPARC held on 14 June 2022 in New Delhi, all the members of its General Council have submitted memorandum to the Hon'ble Union Finance Minister with copies endorsed to The Secretary, DFS, MOF, GOI & The Chairman, IBA, Mumbai on various demands of Retirees which remain unresolved for long. This is as part of the ongoing agitation plan chalked out by our parent organisation.

As the next phase of the programme, it was suggested that the entire membership of all the affiliates do submit similar memoranda to the authorities concerned seeking attention to the burning issues of Bank Retirees viz. Updation of Basic Pension, Uniform DA Compensation to Pre-November, 2002 Retirees, Group Medical Insurance Scheme, Improvement of Exgratia paid to Retirees/Women spouses who retired prior to 1.1.1986, Reckoning of special allowance for calculation of Superannuation Benefits etc. Such memorandum shall be submitted online during the month of August 2022.

Following submission of the online memorandum en-masse by individual retirees there will be various other action plans like Meetings, Demonstrations, Dharnas etc. at district level pan India which will be culminated by a massive Dharna at Juntar Mantar, New Delhi probably by end of September /October 2022.

We request all our members to follow the guidelines and submit the memorandum as advised in the AIBPARC Circular No. 46-22. All our Area Secretaries, Help Desk Teams, Zonal Secretaries, overseeing EC members shall follow up the matter with our members and make it a grand success.

Sub: On-line Memorandum to be sent by members for submission to the Hon'ble Union Finance Minister, the Secretary, DFS, MOF, GOI and the Chairman, IBA for various long pending demands of Bank Retirees.

Our members are aware of the fact that in pursuance of the decisions of the last meeting of the Governing Council of the organisation, all the members of the GC have individually sent memorandum to various authorities within the period 15th July to 30th July, 2022. It has been a remarkable success so far as participation is concerned.

- In the second phase of the agitation, we have already conveyed by our previous circular dated July 22, 2022, that similar such memorandum will be sent by individual members of all our affiliates and other willing Retirees to various authorities throughout the month of August, 2022. Now we are issuing hereunder the detailed procedure of how to operate the on-line memorandum. This is well known to everybody that our earlier programme of similar nature undertaken in December 2020 got a tremendous response from members. We have a fervent hope that this time will not also be an exception.
- Members are first to open our website www.aibparc.in. Just above the photographs of the President and GS, there is a rectangular box of red colour in which it is written "Unresolved issues of Bank Retirees". It is to be clicked.
- A Page will open up containing a letter dated 09.08.2022 addressed to the Hon'ble Union Finance Minister with copies endorsed to The Secretary, DFS, MOF, GOI & The Chairman, IBA, Mumbai on various demands of Retirees.
- At the bottom of the letter, each member will type his full name, mobile number and email id in the specific box given and then he/she will record his/her concurrence by clicking on the box named as "confirm". The mail will automatically go to the three addressees and a return mail will come back to the member concerned. From our experience in the last occasion, it has been found that whenever there is congestion in the line, the return mail to the member may not always come.
- The campaign will remain open for 21 days i.e. upto 31st August, 2022.

All our affiliates are earnestly requested to employ their fullest endeavour to ensure that the members in largest possible number can take part in this campaign. Our relentless struggle will continue and members on completion of this very vital phase of agitation will be advised about the next phase in line with the decisions taken in the meeting of the Governing Council.
