## **Sub: E C Meeting held on 06 May 2019 – Important decisions**

The Executive Committee combined with Area Secretaries of the Forum met on 6<sup>th</sup> May 2019 at FBOA Centre. Com. Tom Thomas, President of the Forum welcomed all Office Bearers and Committee members. The meeting deliberated among other things, issues pertaining to the retirees and other development at national level, especially following the Triennial National Conference of AIBPARC successfully held in Chennai on the 30<sup>th</sup> and 31<sup>st</sup> of March 2019. Com. Paul Mundadan, Senior Vice President, AIBOC and our EC Member addressed the committee and extensively covered developments with respect to Bipartite Talks with special stress to retirees' issues. It was reiterated by him that AIBOC would not be a party to the Bipartite Settlement unless and until the retirees' issues are positively resolved. Further, Com. Paul reported that discussion with Management of our Bank on the Charter of demands submitted by FBOA, are in progress wherein some issue relating to retirees are also in consideration.

**PF Case:** Our members may be aware that PF authorities had filed a SLP before the Hon'ble Supreme Court. Recently Bank has filed a counter in defense of the case, covering all the aspects of the case. Now FBOA/FBROF will be filing a joint counter petition, shortly. Developments, in this respect will be posted in due course.
