Submission of Life certificate by Pensioners and Family Pensioners

To All Members,

To facilitate uninterrupted payment of Pension and Family Pension by the Bank, the beneficiaries are supposed to file a Life Certificate every year. On our continuous request, Bank in the previous years had launched a paperless /digital platform **Fed-e-Life** which enabled our members to file the life certificate from the convenience of their home, totally avoiding the need to visit branches/offices of Bank to submit the certificate in physical form.

Bank's circular issued in this connection is reproduced hereunder. Pension beneficiaries may please note the last date for submission of Life Certificate digitally or otherwise is 30 September 2022. The link to access the Fed-e-Life portal is given in the circular.

Pension beneficiaries of the Bank are required to submit Life Certificate to the Trustees of The Federal Bank (Employees') Pension Fund, every year, to ascertain their eligibility status so as to ensure uninterrupted receipt of Pension.

Pension beneficiaries are requested to submit the Life Certificate digitally latest by 30th September 2022, preferably by using Fed-e-Life Platform. Fed-e-Life platform can be accessed by clicking the link as given below, for submitting the Life Certificate Digitally.

Pension beneficiaries can also submit the Life Certificate digitally through any of the Branches of the Bank using AADHAAR based Biometric Digital Life Certificate Platform.

All concerned may please note that, Digital Life Certificate is based on AADHAAR validation and hence, only those beneficiaries having valid AADHAAR can submit the Life Certificate digitally.

Other beneficiaries (without valid AADHAAR) may submit hard copy of the Life Certificate through any of the Branches/Offices of the Bank.
