## Submission of Life certificate by Pensioners and Family Pensioners

In order to ensure uninterrupted payment of Pension and Family Pension from the Bank, the beneficiaries need to submit a Life Certificate every year.

We may remember that, based on our fervent request and follow-up, last year Bank had launched a novel paperless /digital platform **Fed-e-Life** so as to enable our members to file the life certificate from the convenience of their home, totally avoiding the need to visit branches/offices of Bank to submit the certificate in physical form, especially in the pandemic season . It was welcomed by our fraternity enthusiastically. As a move to further the Digital platform, has introduced an AADHAAR based Biometric Digital Life Certificate platform which facilitates submission of Life Certificate digitally through any of our Branches. Those who are unable to use these facilities are free to use the conventional system of submitting life certificate in physical form by visiting any of our Branches. We are arranging to send hard copy of the Life Certificate to our super seniors who are not conversant with online submission and using WhatsApp facility. If any family pensioner need a copy of the certificate, they may request it through their WhatsApp group, mentioning their postal address.

Bank's circular issued in this connection is reproduced hereunder. Members may please note the last date for submission of Life Certificate digitally or otherwise is **30 September 2021**.

### **Fed-e-Life: Digital Life Certificate for Pensioners/Family Pensioners of the Bank**

Pension and Family Pension beneficiaries of the Bank are required to submit Life Certificate to the Trustees of The Federal Bank (Employees') Pension Fund, every year, to ascertain their eligibility status so as to ensure uninterrupted receipt of Pension/Family Pension.

As a part of Bank's endeavour to migrate fully to digital/paperless model, a new platform i.e. **Fed-e-Life** was introduced last year (Live Photo verification) to facilitate our Pension/Family Pension beneficiaries to submit their Life Certificate digitally.

In addition to the Fed-e-Life platform, an AADHAAR based Biometric Digital Life Certificate platform has also been introduced recently, wherein the Pensioner/Family Pensioner can submit the Life Certificate digitally through any of our Branches. Any changes in Address, Mobile Number, e-mail ID etc., can also be updated while submitting the Digital Life Certificate.

Digital Life Certificate is based on AADHAAR validation and hence, only those beneficiaries having valid AADHAAR can submit the Life Certificate digitally. In the case of other beneficiaries (without valid

AADHAAR), the existing practice i.e. submitting hard copy of the Life Certificate through any of our Branches/Offices may be continued.

The Pension/Family Pension beneficiaries can submit the Life Certificate (preferably digitally) latest by 30<sup>th</sup> September 2021. Those who have already submitted the hard copy of the Life Certificate for the current year, need not submit the same again, digitally.
