As informed earlier, Bank has been taking all out efforts to release the arrears of PF amount received from the PF Organisation to all eligible members at the earliest since past 3 weeks. HR Department has been waiting for a clearance from Bank's Statutory Auditors which caused a little delay in the matter.

We are very glad to announce that the Bank has obtained clearance today morning as to Zero tax liability and hence the Bank will be crediting the eligible amount to each staff in their accounts today itself. However in the case of a few of the eligible ex-employees there may be a possibility of a bit more delay as a few cases require more scrutiny for finalising the eligible amount. The work is earnestly going on at HR Dept and the matter is being followed up by the Central Office.
