## ONLINE SUBMISSION OF MEMORANDUM TO IBA/FINANCE MINISTER LAST DATE FOR SUBMISSION IS 31<sup>ST</sup> AUGUST 2022

To All Members

Attention of all our members are invited to our E circular No. 25 dated 10<sup>th</sup> August 2022 regarding submission of online memorandum by all members of affiliates of AIBPARC to the Hon'ble Union Finance Minister with copies endorsed to The Secretary, DFS, MOF, GOI & The Chairman, IBA, Mumbai on various demands of Retirees which remain unresolved for long.

As decided in the last Governing Council of AIBPARC held on 14 June 2022 in New Delhi, all the members of its General Council have submitted memorandum in the month of July 2022. This is as part of the ongoing agitation plan chalked out by our parent organisation. As the next phase of the programme, it was suggested that the entire membership of all the affiliates do submit similar memoranda to the authorities concerned seeking attention to the burning issues of Bank Retirees viz. Updation of Basic Pension, Uniform DA Compensation to PreNovember, 2002 Retirees, Group Medical Insurance Scheme, Improvement of Exgratia paid to Retirees/Women spouses who retired prior to 1.1.1986, Reckoning of special allowance for calculation of Superannuation Benefits etc.

Though most of our members have submitted the online memorandum few are remaining to be submitted. **By Clicking on this link <http://aibprc.co.in/UserReg/savedata> you will be directed to the Memorandum Page directly.** Next plan of action of AIBPARC is to organize a Massive Dharna in front of Jantar Mandir, New Delhi on 26<sup>th</sup> September 2022 with maximum participation.

All our Area Secretaries, Help Desk Teams, Zonal Secretaries, overseeing EC members are requested to get in touch with our members who are yet to submit and make sure that 100% of our members have participated in this action programme.
