Distribution of PF Settlement amount

We had reported through our previous circular the victorious Finale of the PF Case following the Apex Court Decree. Our Forum and FBOA have been in constant contact with the HR functionaries for achieving an earlier distribution of the settlement amount due to the employees. The Bank is striving hard to give a final shape to the things. One of the main impediments on the path of implementation is the pandemic; majority of the staff of HR are affected with the Covid. Also, the case involves more than 5K beneficiaries which comprises Retirees, Resignees, Family Pensioners, Non-pensioners, others those who were ceased to be in the service owing to various reasons etc. In many cases the Department has to access to old records and files of the employees. As such, it is gathered that the final payment will take place after a few more days. We have anyhow requested the Bank to expedite the matter in view of the gravity and volume thereof.

Let us hope for an early pay out.
